Old Business:

Commissioners' Report:

Utilities - Frank reported made his rounds of the City and no street lights were out. Contacted MSD for the drainage clean-up. Contacted the Water Co about the broken pipe on Bay Run & Lunenburg.

Public Health & Safety- Darren report 12 Written/Verbal Warnings, 14 Citations and 30 notices given out by patrol. Toured the area for parking violations and safety concerns. Mailed parking letters.

Property Maintenance- Glenn reported that GreenScapes cut all the dead trees in the drainage portion of the open space and also did trimming of low hanging limbs. Replaced the landscaping in the Northumberland/Halifax island that was damaged from the winter auto accident. GreenScapes was very slow in mowing of the islands, he called the manager Anthony Hans many times on this matter. Spoke with homeowner on a bush that was overgrown, and the owner said he would take care of it himself. Notified Metro of a home that is in a state of disrepair.

Road Maintenance- Krystal reported walked through the City and found a bush overgrown in the sidewalk of Halifax. Phoned and emailed Roscoe with Flynn Brothers to inquire about our speed hump.
