The meeting was called to order at 7:00 pm by Mayor Stonum with motion by Commissioner Metcalf and seconded by Commissioner Maupin. The Pledge of Allegiance to the Flag of the United States was recited; followed by a moment of silent prayer.

## City Audit

Conference call was made to Stephanie Hahn with Bramley and Ackley. She explained the provided handout created for the City Audit FY 2025. Motion was made to accept the City Audit FY 2025 by Mayor Stonum and seconded by Commissioner Metcalf. Roll Call vote: Commissioner Maupin – Yes, Commissioner Metcalf – Yes, and Mayor Stonum – Yes. The handout shows that COWH followed the U.S. Accounting Principles. Ms. Hahn also explained that although it might be cheaper to do bi-annual audits, audits have to bring information up-to-date which increases the cost. Final audit report will be provided by Ms. Hahn to DLG on Wednesday November 19 with a copy to Mayor Stonum.

Introductions were made for our visitor: Mayor, Commissioners, Treasurer, City Clerk and City Attorney

#### Citizen's Concerns:

- Zach Waters brought his plans to build a Little Free Library box on his property to show the Commission. Mayor Stonum asked why he wanted to build this and he said it was because his wife wanted one and they both love to read. After his plans were presented, motion was made to allow this to be built by Mayor Stonum and seconded by Commissioner Maupin. Vote was unanimous.

Minutes: The October 2025 minutes were brought up for approval. Motion was made by Commissioner Maupin to approve the minutes and seconded by Commissioner Metcalf. Vote was unanimous.

Financial Report: The October 2025 Financials had been distributed to the Commission for review and posted on COWH website prior to the City Meeting. Motion to approve was made by Commissioner Maupin and seconded by Commissioner Metcalf. Vote was unanimous.

Expense Review: The cover sheet of November invoices along with invoice copies were passed around for Commissioners to review and initial. No approval motion was needed since Commissioners had already initialed and approved

# Legal:

Delinquent Property Taxes - 2025 and previous years.

- Treasurer Small has the 2025-2026 delinquent property tax listing to give to Attorney DeWees. There are 35 delinquent properties totalling \$11,700. Motion to give the listing to Attorney DeWees was made by Mayor Stonum and seconded by Commissioner Metcalf. Vote was unanimous.

- Duplicate tax payments have been received from 10 properties totally \$3,043.64. A motion was made by Commissioner Maupin and seconded by Commissioner Metcalf to return these duplicate tax payments to the property owners. Treasurer Small would need to send monies to Kentucky State Unclaimed Property
  Department if previously issued checks have not been cashed.
- As far as delinquent property taxes from previous years, Attorney DeWees will contact previous city attorney, Stephen Schwager, to obtain previous records of any procedures/liens against those properties. Old liens roll over to new owners since the sale must have slipped through title search. Mayor Stonum suggested that Attorney DeWees contact Stephanie Hahn with Bramel and Ackley.

### Old Business:

- Welcome Ambassador no change/update
- Commissioner Maupin advised that she has still not heard back from Connor with EcoTech and the issue of extending yard waste pickup through January 5, 2026.
- Mayor Stonum informed the Commission that he had read an article about not raking leaves because they provide warmth and coverage for bugs, butterflies and birds. Commissioner Maupin suggested that COWH document the number of yard waste users to decide whether to keep providing yard waste pickup in the future.
- Mayor Stonum asked that Attorney DeWees check if COWH has received payment from property owner for their part of the cost of the tree removal.
- Commissioner Metcalf advised we will be using Channel 10 tonight for radio check.

### **New Business**

- Mayor Stonum advised that it is time to decide on salary increase for the Commissioners. An agreed upon increase would become effective January 1, 2027, but must be decided by May 1, 2026. We will wait until December meeting when Commissioners Beville and Recendez are able to attend to begin discussion.
- Christmas decorations. When should the decorations be put up? Harold Hall used to help when he was a commissioner. Mayor Stonum suggested that we asked Mr. Hall to help again and to find out how much he would charge. Motion to do so was made by Commissioner Metcalf and seconded by Commissioner Maupin. Vote was unanimous.
